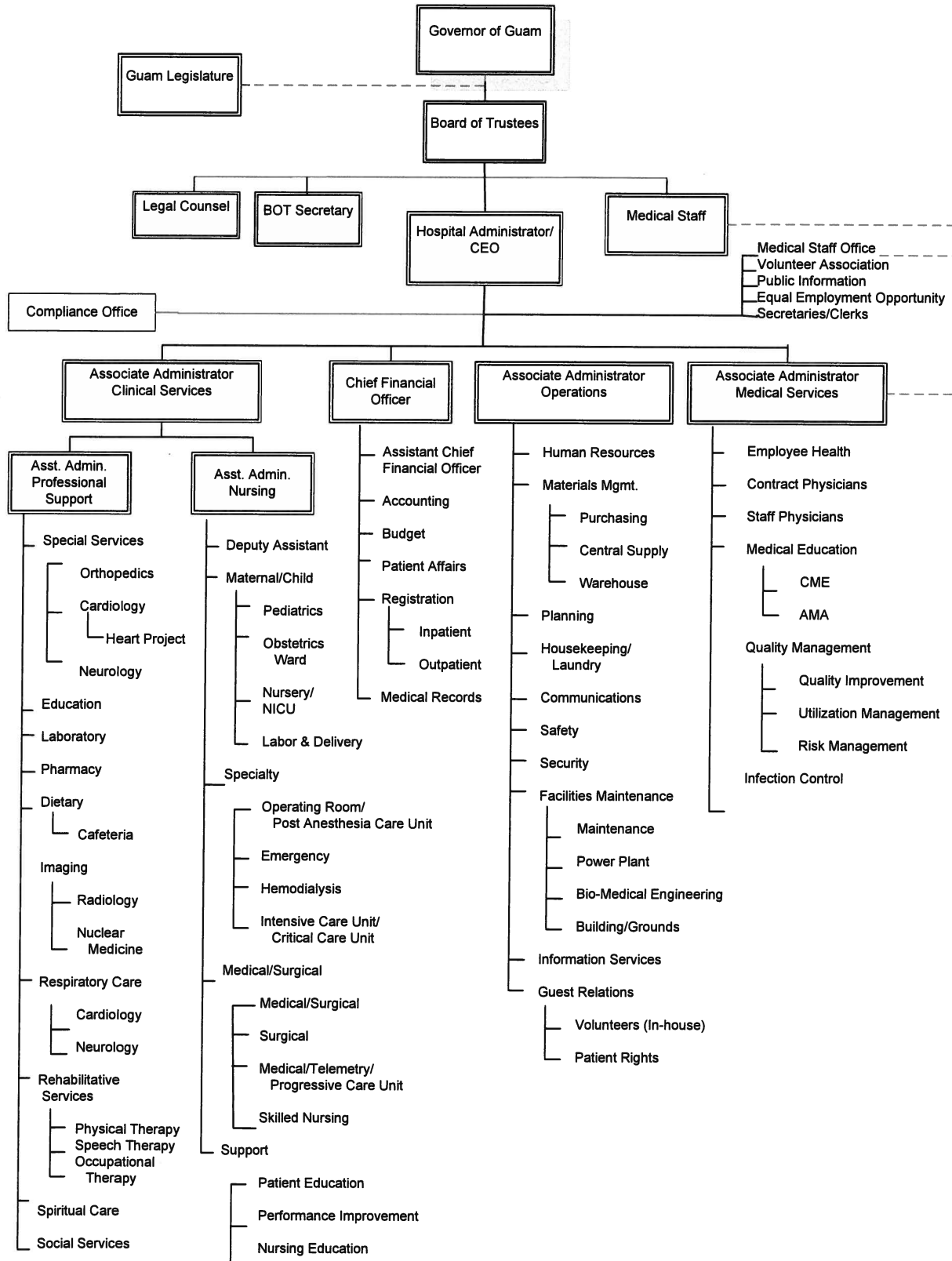



GUAM MEMORIAL HOSPITAL AUTHORITY ORGANIZATIONAL CHART
