

Magnetic Resonance Imaging (MRI) scanners produce non-ionizing radiation. That's good news! In other words, an MRI is less risky than many other radiological modalities, but there are still some serious risks due to the magnetism. Some of those risks include a projectile force from a magnetic object soaring into the MRI scanner, along with potentially damaging implanted devices and other medical equipment, e.g., ventilators, wheelchairs, IV pumps, etc. Let's discuss the risks associated with magnetism and the importance of MRI safety.

Use & Function

The MRI scanner is a large, spinning magnet that can produce detailed images from any part of the body. When the body is placed in this strong magnetic field with radio frequency pulses, the MRI can detect tissue abnormalities which makes it a valuable tool in the diagnosis and monitoring of many medical conditions.

The MRI Zones

To provide safe patient care in a magnetic environment, precautions and procedures must be hardwired into daily workflow processes. The American College of Radiology (ACR) sets nationally recognized standards for safe practices with the establishment of four (I-IV) MRI safety zones. Zone I is in the public area and leads into Zone II. In Zone II, patient preparation begins which commonly includes patient gowning, obtaining medical history, and conducting safety screening.

Upon entering Zone III, you are crossing a safety threshold! Yes, this is a critical touchpoint in the safety process. According to ACR, unsecured access to Zone III can result in serious injury and even death due to the MRI scanner's particular magnetizing environment. ACR recommends this zone should be demarcated to clearly indicate it as potentially hazardous. Whether you choose Zone I or II as the place to conduct the screening, be sure to make it a hard rule for anyone and everyone to be screened before entering Zone III. (Safety Tip - Test your hospital's safety screening process(es) to see if anyone, can access Zone III without first being screened. Remember, there are no exceptions to this rule - Everyone must be screened!)

The compliance tip of the month for August is focused on an organization's Quality Assessment & Performance Improvement (QAPI) program.

Hospitals are often cited when based on a review of documents or staff/leadership interviews a surveyor is not able to see how services or departments are incorporated into the QAPI program.

The program must also include the organization's compliance with the NFPA life safety code and care environment. Additionally, CMS now requires surveyors to evaluate not only the data and analysis itself but how the organization goes about ensuring that there is sustained improvement over time in order to determine the success of the overall program.
